ABOUT THE TRAINER: Mara Hsu

Mara is currently working with the Rocky Mountain Research Center and partnering with the Early Childhood Council of the San Luis Valley on a public health practice-based core research project designed to reduce the intergenerational transmission of adverse childhood experiences (ACEs) in the San Luis Valley. She believes in all children having a solid social and emotional foundation. Mara enjoys spending time with her husband of 20 years and two adult sons.

Attendance Policy: As per effective Jan 2021 guidance of Pyramid Colorado, in extreme circumstances, a participant may miss 2 sessions of class, participant must make up the missed sessions within 6 months of the last training session of the series. To receive a certificate of attendance participant must complete ALL 18 sessions. Participants will need to re-enroll in a new training if they miss more than 2 sessions of the training.

Orientation is mandatory as we will be reviewing the attendance policy as well as other important topics related to the 18 sessions.

Structure of Training: The materials are developed so participants will be able to apply strategies and tools in their practice. The presentation will be delivered in a manner that systematically breaks the content into 18 sessions with specific topics and strategies, which provide concrete examples based in a variety of settings (center-based and home).

There will be a 1-hour lunch break along with frequent movement/stretch breaks during the day.

Pyramid Plus Approach Training (delivered by Pyramid Plus Certified Trainer) meets the state requirements for Child Guidance Strategies (ECE 103).

Targeted Audience: Early Childhood professionals and others working to improve the social emotional health of children Birth – 5 years; including administrators, coaches, trainers, teachers, Early Childhood Mental Health consultants and specialists, Early Intervention providers, and other health professionals are encouraged to attend.
